Finance Statute of the Southern Province, No. 7 of 1990

REGULATION UNDER SECTION 77 (1) (a)

BY virtue of the powers vested in me under Section 77 (1) (a) read together with Section 40 (2) of the Finance Statute of the Southern Province No. 7 of 1990, I Matarage Sirisena Amarasiri, Chief Minister and the Minister-in-charge of the subject of Finance do by this regulation prescribe (a) the Bank to which the stamp duty be paid; and (b). The form in which the Bank shall issue a certificate as follows:

- (a) Bank of Ceylon, Galle Bazaar Account No. 4662C;
- (b) (i) Form BC/E/SP to be used by the branches of the Bank of Ceylon within the Southern Province; and
- (ii) Form BC/E/OP by the branches of the Bank of Ceylon outside the Southern Province and as specified below.
