The rate of Turnover Tax of 01 percent imposed by Part I of the order published in the Extraordinary Gazette No. 644/29 of 12th January, 1991 and the rate of Turnover of 02 percent imposed by the order published in the *Gazette Extraordinary* No. 1469/2 30th October, 2006 and No. 1469/32 of 02nd November, 2006 of the Democratic Socialist Republic of Sri Lanka shall cease to apply, upon the coming into effect of this order, in respect of any turnover arising after the midnight of 15th December, 2006/16th December, 2006. in respect of only the Turnover of the business referred to in paragraphs (a) and (b) of this order.
