#### Southern Province Provincial Council Finance (Supplementary Provision) Statute No. 02 of 1994

##### ORDER UNDER SECTION 2(1)

BY virtue of the powers vested in me under Section 2(1) of the Finance (Supplementary Provision) Statute No. 02 of 1994 Southern Province Provincial Council, I Gustinnawadu Shan Wijayalal De Silva, Chief Minister and Minister of Finance of Southern Provincial Council, do by this order, fix the following rates and regulations shall come in to effect from the 01st January, 2010.

##### REGULATIONS

These regulations (Imposition of Tax on Prize competition) may be cited as the regulation of Southern Province Provincial Council Finance (Supplementary Provision) Statute No. 02 of 1994 order under Section 2(1) and (2).

- (I) A prorate tax shall be charged on the total value of the prizes awarded at every prize competition held within the Southern Province calculated in the following manner :

<i>Total value of the prizes</i>	<i>Pro Rate Tax</i>
Rupees Twenty five Million (Rs. 25m) or less	10%
More than Rupees Twenty five Million (Rs. 25m)	25%

- (II) (a) The Licence shall be in the form set out *i. e.* Schedule "B"  
(b) The application for a licence shall be in the form set out in Schedule "A" hereto and shall be accompanied by a fee of Rupees One Thousand (Rs. 1,000) in cash.

Any person who intends to promote or conduct a prize competition should be obtained the licence for the purpose in terms of provisions in this statute 14 days before the announcement of the prize competition.

- (c) The following documents shall be submitted together with the application for a licence, namely.
- The certificate of Registration of the applicant (if the applicant is an Institute or an Organization) and a certified copy of such certificate.
  - The approved document which contains the rules or conditions as the case may be, applicable to the prize competition together with certified copies of such documents and a full and accurate description of the prize to be awarded at such competition.
  - A receipt or any other document in proof of payment of the licence fee.
- (III) Place or premises where a Prize Competition can be conducted or promoted under this statute shall be announced.
- (IV) The return *i. e.* Schedule "C" as mentioned in Section 2(2) of the Financial Statute shall be submitted to the Provincial Commissioner of Revenue.

In these regulations "Financial Statute" means the Financial Statute No. 7 of 1990 of Southern Province Council and the finance statute (Supplementary Provision) No. 02 of 1994 such Council.
