Finance (Amendment) Statute No. of 2011 of the Southern Province Provincial Council

Be it enacted by the Provincial Council of the Southern Province of the Democratic Socialist Republic of Sri Lanka as follows:-

| <p>(1) This Statute may be cited as the Finance (amendment) Statute No. of 2011 of the Southern Province Provincial Council and shall come into operation on such as the Governor may approve it.</p> | <p>Short Title and date of operation.</p> |
| <p>(2) The following sub sections are hereby inserted in the Principal Statute immediately after the section 62 of the Finance Statute No. 07 of 1990 of the Southern Province hereinafter referred to as “The Principle Statute” and shall have effect as sub section 62(1) and 62(2) of the Principle Statute;</p> <p>62(1). An assessor’s opinion on the value of the property shall be obtained for the purpose of stamp duty for such property before executing an instrument for any immovable property in the province and the assessor shall give his opinion in writing to the person who applies for it in the Specified Form and pays a fee of 250 Rupees;</p> | <p>Insertion of section 62(1) and (2) to the Principal Statute.</p> |

62(2). Sub section 62(1) shall have effect on each instrument executed on or after the date on which this statute comes into operation and 62 shall have effect on every instrument executed prior to the coming into operation of this statute.

Amendment of subsection 78(1) of the Principal Statute.

- (3) Section 78 of the Principal Statute is hereby amended in subsection 78(I) of that section by the insertion immediately after the words “full names and addresses of parties”, of the words date and number of the document on which the assessor records his opinion under subsection 62(1)”
- (4) In the event of any inconsistency between the Sinhala, Tamil and English texts of this statute, the Sinhala text shall prevail.

ORDERS

- (01) This orders are cited as the orders with regard to the Payment of Stamp Duty under section 40 of the Finance Statute No. 07 of 1990 of the Southern Province Provincial Council and shall come in to operation on 01st January 2012.
- (02) The use all adhesive stamps of different values imposed by the *Gazettes extraordinary* of the Democratic Socialist Republic of Sri Lanka No. 644/29 of 12th January 1991, No. 648/5 of 05th February 1991, No. 670/4 of 9th July 1991 and No. 1478/16 of 04th February 2007 must be repealed.
- (03) It is hereby required to use the certificate obtained by paying money to the bank for the purpose in terms of section 40(2) of the Finance Statute No. 07 of 1990 of the Southern Province Provincial Council in place of using adhesive stamps.
- (04) The amount payable for stamp duty shall be paid to the following Account Numbers in Bank of Ceylon or People’s Bank in Sri Lanka in accordance with the following forms:-
 - (a) (I) Bank of Ceylon, Bazaar Street, Galle. The Account Number of the stamp duty collection account of the Provincial Commissioner of Revenue, Southern Province - 402478
 - (II) People’s Bank, Fort, Galle - The Account Number of the stamp duty collection account of the Provincial Commissioner of Revenue, Southern Province - 013-1001-00021541
